| April     | Multipe Exposure                       | 21/04/2025                                 | Phillip de Lange   | Multiple images used together to create a new photograph either in camera or using image manipulation application (e.g.Photoshop).<br>Manipulation is allowed as per PSSA rules.   |
| Mei       | Mono - High contrast / Juxta position  | 19/05/2026                                 |                    | High contrast mono or Contrast could be visual or conceptual(old/new, calm/chaos) Mono as per PSSA definition<br>Manipulation is allowed as per PSSA rules.  |
